#### **MBI CHAIR REPORT – September**

**Step 9:** Made direct amends to such people wherever possible, except when to do so would injure them or others.

Spiritual principle: Love.

Like many others, I felt reluctant to move into this step. However, I had done Steps 1 through 8 with my sponsor, and with the help and guidance of my HP, my ability to trust this process of working the 12 Steps was growing.

The OA 12 & 12 advises "checking out our words and actions ahead of time with someone more experienced than we are, someone who is detached from the situation." (p. 76 of the first edition) In this way we can be more confident that we will not "injure them or others" by what we say or do. My sponsor guided me to write out my amends and review them with her. Sometimes, I would continue to pray for guidance and write again until my sponsor felt I was ready to make the amends. Some amends were only in writing for those I did not know how to reach or for those no longer living.

My love for others has grown through this process, and continues to grow as I continue to work the Steps. The Promises that we read in our OA meetings are at the end of the pages on Step 9 in the Big Book. That section concludes "They (the Promises) will always materialize if we work for them." (Alcoholics Anonymous, p. 84)

#### What does MBI provide for our member groups? (Conclusion, cont'd from August)

#### MBI strives to serve our member meetings and to reach out to those still suffering.

Intergroups are a part of the OA service structure, providing a link between World Service, Region, and the individual meeting groups and OA members. Every meeting in MBI is entitled to send a representative to the monthly Intergroup meeting. MBI requests that Intergroup Reps have 90 days of abstinence to vote. Having a representative from your meeting at the MBI meetings is a way to have your meeting's concerns heard by MBI and one way of getting information back to your meeting. MBI also sends the monthly Highlights to Designated Downloaders, volunteers who make announcements in their meetings.

In 2017, MBI completed an Intergroup Inventory. The results are posted on the MBI website (see drop down menu under ABOUT MBI in the upper right corner of the OA MBI website home page). An MBI committee has created a survey which is close to being completed. Our survey will be a way for members to give their input to MBI.

# **MBI TREASURER REPORT - July 2018**

Income for July was \$2584.36, of which \$1944.25 was in the form of group donations. Thank you to all the groups who donated, a list appears at the end of this report.

We received 3 more retreat entries, total \$525 for the month. For those who are keeping track, we have a total of 10 retreat entries as of the end of July, or \$1750.00 out of our \$4300 checking account balance. Other income sources were \$ 42.50 in personal literature sales (offset from literature purchase), and \$30.00 from the MBI 7<sup>th</sup> tradition collection.

Expenses for July were mostly routine: office rent \$445.00, webmaster \$50.00, Verizon \$155.95, postage \$26.15, donation to hospital for MBI meeting and July workshop \$50.00, website \$76.70, office work (Marina) \$337.50, OA literature \$175.28 (of which \$42.50 was reimbursed), \$25.00 for Region 6 as deposit for IGOR training (we will get it back when people go to the training in September before the R6 Assembly). We also made our quarterly donations to Region 6 and WSO of \$250 each.

I have gotten some questions about our donations. Our quarterly donations are listed in our bylaws under the duties of the treasurer (p.8 in the bylaws manual). We give the same amount every quarter (\$250 each, or a total of \$1000 annually to R6 and \$1000 to WSO) regardless of what we receive in donations from groups or any other income we get from events or sales. We don't follow the 60/30/10 system because our expenses are higher than those of a meeting group, and some months our expenses exceed our income. You can be sure that MBI is carefully safeguarding your group donations and using them in accordance with our purpose, to further the OA program and work for OA as a whole within the Intergroup, to maintain a communication center, to work for unity, and to choose Region Representatives to R6 and Delegates to World Service. # **MBI BYLAWS Committee Report – July**

We had an hour of committee meetings followed by the MBI meeting under the old setup, but we don't have the space for that now and the committees meet on their own time. Step 9 "Made direct amends to such people wherever possible, except when to do so would injure them or others." The series continues with discussion of Step Nine. Both speakers describe their own personal experience with doing Step Nine, giving specific examples of amends they have made. In addition, they emphasize the need to make amends in order to refrain from returning to compulsive eating, and to be released of the negative feelings or turmoil created by holding on to the amends. Also discussed is reviewing the list and practicing amends with a sponsor, remembering the principles of forgiveness and love for others, and that the focus of the amends should be on one's own role and behavior, being specific and actually making amends and changes. Suggestions are also provided for making amends to people who have died or are no longer in one's life. The second part of Step Nine is also stressed, ensuring that no further injury or insult occur due to inappropriate amends.
