#### **MBI CHAIR REPORT - February**

#### **Concept Two - Conscience**

"The OA groups have delegated to World Service Business Conference the active maintenance of our world services; thus, World Service Business Conference is the voice, authority and effective conscience of OA as a whole."

What is conscience? That inner feeling or voice that is considered as acting as a guide to the rightness or wrongness of one's behavior. Conscience is the inner sense of what is right or wrong in one's conduct or motives. In the food, that is, in untreated addiction and compulsive food behavior, I could not feel or hear my conscience. There were feelings and instincts within me but they were numbed by excess food, excess weight, and shame. My "quilty conscience" did not quide me to right/healthy behavior, it kept my thoughts and [limited] actions negative and harmful. "Sugar highs and crashes", food and flour fog, and compulsive binges and purges took the place of the feelings and inner sense of connection with others and the next right behavior.

In recovery, with abstinence and the treatment of our disease, each OA member's conscience can be felt and heard to allow each member's next right action. With more than sixty thousand individual members from 6,500 land based groups in more than 75 countries, and with members of virtual meetings(phone, on line, etcetera) how do we know/learn what is "right" or "wrong" for OA as a whole?

In OA we seek a **group conscience**, that is, if not a unanimous, then a significant consensus

of viewpoints of whether to support or oppose certain changes or actions within or by a group [meeting], Intergroup, Region and for the entire, worldwide membership of OA.

In order to get a group conscience at a group meeting level, we convene a business meeting, every 3 months and members who attend the meeting regularly get a voice and a vote. Sometimes the group conscience wants to make changes in the group meeting format or changes in the service positions. As we know, there is no president, queen or king of OA and each member, whether in a group with lots of regularly attending members or with only a few, has the opportunity to speak and each member has one vote. There are "no VIPs" other than each member being a VIP.

OA group conscience from the many meetings connected to an Intergroup happens in a similar way. Each meeting can send a Representative to the monthly Intergroup meeting and voice the group's point of view on Mass Bay Intergroup action plans for service. And so on within the OA service structure which is represented by an upside down/inverted pyramid. The OA members who regularly attend MBI group meetings elect a Representative to attend the semi-annual Region 6 assemblies. MBI is eligible to send one "rep" with one vote at Region 6 assemblies, for every 15 meetings connected to the Mass Bay Intergroup. The members who attend the monthly Mass Bay intergroup meetings also elect 1 Delegate for every 10 meetings connected to the Intergroup. The Delegates attend the annual World Service business and have one vote each. The Delegates have heard from the Intergroup and the group meetings what the significant consensus is about motions that will be heard at the business conference. However,

Delegates are able to vote their individual "conscience" after hearing from the other Delegates at the business conference.

The ability to vote one's conscience is yet another gift of recovery and serves OA across the world. To be teachable and of sane and happy usefulness as a trusted servant is humbling and an honor. It means yet another OA member has been freed from the bondage of food and of self. Bondage that did not allow the member to feel or hear her/his own feelings or inner voice. Thank you OA and thank you for the 12 Concepts of World service which begin with each individual member and contribute to the broad span of members who are the "top" of the OA service structure. ## **MBI Treasurer's Report December 2018**

December, end of the year, and my last report as treasurer before I turn it over to Mary P. from Quincy who will be doing these reports starting in January. Our income was all donations this month, \$1101.00 from groups, \$50.00 from the MBI 7<sup>th</sup> tradition collection. A list of groups donating will appear below, thank you to all who supported MBI. Please remember to send your donations to MBI, PO Box 74, Arlington MA 02476-0001 and indicate which group is sending the check or money order by listing the meeting town/day. One reason why our December expenses were higher than usual is that our annual bill from our accountants came in for \$897.00. Other expenses were routine: \$29.25 for website, \$50.00 for webmaster, \$50.00 contribution to the hospital for use of meeting rooms for MBI and workshop, \$445.00 for office rent,

\$156.06 for Verizon, \$29.99 for office supplies, 71 cents for postage (for an envelope that took 2 weeks to arrive), and \$205.00 to Marina for office work and a holiday bonus MBI voted for her. Upcoming expenses in January will be our office insurance policy, quarterly donations to Region 6 and World Service, and 1099s for Pat and Marina (already done by Jean). I am working on "how to do treasurer" instructions for Mary and we will be going to the bank to take me off the account, get a debit card for Mary, and get Cathie B. on the account as new MBI chair, she may want a debit card as she also represents us at Region 6 and WSBC. Looking back at the end of December 2017/January 2018, we have more in the checking account now than last year, but we also haven't paid a deposit for the new retreat yet. Thank you for allowing me to be of service. I am in the process of packing up the file boxes that go back to 2004 (from Neil, who was treasurer before my first term in 2006), these will gradually be re-homed. I may continue to serve MBI in another capacity, will see if I am needed anywhere.

### **MBI Office Report January 2019**

The office is running well. Marina is preparing for the Addictions Conference in early March by going through the suitcases to determine what literature we have and what we will need to order, if anything. WSO sent an email that a new Newcomers booklet was being produced that will replace the Newcomers packet. The new booklet would include (some or all, unclear) of the individual pieces (for example 15 Questions) that are now in the packet. At MBI, we do our own version of the packet because we don't include Dignity of Choice that the WSO version had, and it sounds like the new booklet would include sample food plans. Our version also includes an MBI

meeting list which the World Service version does not. World Service is selling the new booklet for \$1. We may order a copy to look it over and to see what it includes. Meetings can order their own literature from World Service and it might be helpful to advise meetings just what this new booklet contains in case they decide to order some since they are cheaper that the MBI version and 1 booklet might be easier for a newcomer to read than a bunch of shorter pamphlets. It is not clear if WSO is trying to reduce inventory of pamphlets, as they have declared a moratorium on new literature. We will have to wait and see what this will mean for us since we include pamphlets in our professional outreach packets for medical, therapeutic, clergy, and employee assistance programs. 


