MBI CHAIR REPORT - April

Concept Four of the Twelve Concepts of OA Service: "the right of participation ensures equality of opportunity for all in the decision making process."

Principle: Equality

Don't Isolate, Participate!!" proclaims a t-shirt I bought from an MBI sponsored event years ago. How do I do that? The disease tells me, "They don't need me, my voice or my vote." The disease wants me to stay away, to compare, judge myself and others and single out other members to put on a pedestal. The disease tells me there must be someone to "run the show."

Recovery tells me "I am one of", I am a part of this worldwide fellowship and that I belong. The only requirement for membership is the desire to stop eating compulsively. The only one not on equal footing with each member is each member's respective Higher Power, as each understands his/her Higher Power. We are each compulsive eaters/compulsive overeaters who unite as equals and each of us has a "right and responsibility to participate in the decision making process (group conscience) at business meetings."

The right of attendance to, presence at and participation in business meetings at the group or "local" level, is equal and open to all. The extent of the participation is typically part of the group meeting's format for business meetings. Typically, members who regularly attend the meeting have a vote at that group's business meetings. As we know there is no president or ruler of OA, each regularly attending member has one vote. The participation of as many eligible member voters as possible ensures a true "group conscience" will be revealed. The active

participation of as many eligible member voters as possible also provides the surest opportunity for significant consensus. As we know, the OA service structure is built on significant consensus, not on merely outnumbering members with alternative proposals, positions and/ or views.

In addition to having a right and responsibility to participate, it is a hugely meaningful service. The member is committed to their recovery, committed to attending at least one group meeting regularly, and voting on issues which affect the group. The member may then ask to provide service or nominate/vote for, a member able and willing to provide service as a Representative to the Mass Bay Intergroup "MBI" business meeting (see page 5 for next meeting information.) A member's service as a Representative or Alternate Representative from a group meeting brings that group's views and vote into Intergroup decisions. Mass Bay Intergroup supports 39 meetings, which means there are at least 39 different groups to hear from for significant consensus.

Participation at MBI provides the service opportunity for Representatives to bring their own decision and vote, to the business meetings of the 41 or so Intergroups associated with Region 6. Also, votes are needed from Delegates, OA members able and willing to attend the annual World Service business meeting in New Mexico. The OA service structure, built on 12 concepts of service and 12 spiritual principles, including equality, ensures that the voice of each individual OA member is heard and participating in, a true group conscience of OA as a whole.

All are welcome to visit MBI business meetings and to experience the strength and hope that

In February, \$64 of our income was for Newcomer Pamphlets/Packets. \$26 was from the 7th Tradition collection at our MBI meeting. \$1314.10 was from group and one anonymous donation(s). Our February expenses included: Our quarterly donations to Region 6 (\$250) and to World Service (\$250) cleared the bank on 2/1. "Been Slipping and Sliding?"

A Reading and Writing Tool

The following are the items 4-6 of thirty questions for use in daily writing and/or discussion with a sponsor by members who want to stop "slipping and sliding." The questions are also recommended for those in relapse who want to recommit to their OA program.

Read the suggested material(s); then reflect and write on the accompanying idea or question.

- 4) Read "Out of Darkness" in Overeaters Anonymous (pp. 143–146). What made the difference that brought the author to renewed abstinence? How would I describe my willingness to accept that this program may be more difficult once my previous abstinence has eluded me?
- 5) Read the story "Agony Aunt Saved My Life" in Overeaters Anonymous (pp. 139–142). The OA pamphlets A Plan of Eating and Dignity of Choice are possible resources for developing an appropriate food plan for continuing in Overeaters Anonymous. Both eating behaviors and specific quantities of each food group are worth considering. Ask: What was my food plan in earlier efforts to work the program? What is it now? What changes do I need to make?
- 6) Read Appendices A, B, C, and D in Overeaters Anonymous (pp. 191–208). "The men and women in OA, who are recovering from their own eating problems, reach out in love to help each other with suggestions, support, and strategies" (p. 192). How is OA a "we" program? How do we depend on each other? Reread pages 192, 195, 201, 205, and 206. Discuss the idea that love from others has helped me find love for myself.
