Income for November was 997.85 from group donations, 333.33 from our share of the 2014 R6 convention, and 25.00 from the MBI 7th tradition collection. Thank you to the groups that donated, a list follows this report.

Our expenses included 936.00 for liability insurance for all of our meetings; if your meeting needs proof of liability insurance please let me know. This is one of the benefits of being part of MBI. The usual expenses for office rent, phone/internet, and pay for Pat our office worker were paid; we paid 84.60 for office supplies and received an adjustment credit of 30.65 for an error on a literature order.

One monthly expense is of concern. Rent at the Stoneham Senior Center is \$100 per month but our 7th tradition collection averages around \$25 per month. I would like to suggest that we look for more affordable space to meet in. or shorten the meeting to reduce the rental fee. If we had more people we might get a higher 7th tradition but that needs more work. I do not think that the meetings that support MBI do so to pay for us to meet in a large room, they donate to support our work and paying so much in rent takes away from other purposes. As you might have noticed our income has been down this year and we need to decide how many people we will send to World Service for 2015. I will have annual figures next month.

I sent Pat, our faithful office secretary, her usual \$100 for Christmas in December as we have in years past and I got a note back
